## *General Rules and Regulations*

- 1. ALL PLAYERS MUST CHECK INTO THE PRO SHOP PRIOR TO TEEING OFF.**
- 2. The hours of operation will be established and published by the Club.**
- 3. The Club shall furnish all food and beverages consumed on the Club facilities, except as permitted by the Food and Beverage Manager.**
- 4. Consumption of alcoholic beverages is restricted to the clubhouse and decks.**
- 5. Employees are not permitted to deliver food or beverages outside areas designated by the Club.**
- 6. Members must not request special personal services from employees who are on duty.**
- 7. No commercial advertisements shall be posted or circulated in the Club, nor shall solicitations of any kind be made on the Club facilities or upon the Clubs stationary, except as permitted by the Club.**
- 8. No petition shall be originated, solicited, circulated or posted on the Club facilities, without prior written approval of the Head Golf Professional.**
- 9. No performance by entertainers will be permitted on the Club facilities without permission of the Club.**
- 10. Dogs or other pets (other than seeing eye dogs) are not permitted anywhere on Club facilities.**
- 11. All formal complaints concerning operations of the Club facilities, its employees, and other matters are to be directed to the Head Golf Professional. All formal complaints must be made in writing and signed by the complainant.**
- 12. No member or guest is allowed in any service or maintenance area of the Club.**

- 13. Violation of the Rules, or conduct in a manner prejudicial to the best interest of the Club, may subject the violator to suspension or termination of membership privileges.**
- 14. The Club reserves the right to amend or modify these Rules whenever necessary and will notify the membership of the change.**
- 15. Appropriate attire is required. Please check with club personnel if you are unsure of your attire.**
- 16. The Club is a payment upon services rendered facility.**
- 17. Any Package I, II or III member may reserve tee times ten (10) days prior to the day of play. Reservations require that a member or members be designated responsible for that tee time, or the reservation will not be guaranteed. Reservations can be cancelled without penalty, or the number of players can be reduced, by calling the pro shop by 1:00 P.M. the day prior to the tee time. In the event that a reservation is not cancelled or corrected in a timely manner, the designated member or members will be charged an "empty seat" fee in the amount of 50% of the green fees that were not cancelled by the deadline.**
- 18. Any member wishing to reserve, and be responsible for, a tee time in which that member is not playing, must make special arrangements with the Head Professional.**
- 19. The Ledges is a spike less facility.**
- 20. Only those with a valid drivers license may operate golf carts. Any member who allows his/her rented golf car to be operated by a person without a license risks revocation of membership.**
- 21. The Club reserves the right to restrict access to the golf course to players only.**
- 22. Seasonal membership fees are non-refundable; they may not be prorated or transferred under any circumstances.**

## ***TERMS OF MEMBERSHIP***

1. **PAYMENT TERMS:** Deposit of \$250.00 for Package I, \$500.00 deposit for package II or III, required by January 27<sup>th</sup>, 2012 with full payment due by March 30<sup>th</sup>, 2012. ***PAYMENT BY CHECK OR CASH. CREDIT CARDS WILL NOT BE ACCEPTED FOR MEMBERSHIP FEES.***
2. **APPROVAL FOR MEMBERSHIP:** I understand that this application will not be acted upon unless fully completed and signed by me. Membership is contingent upon approval by the club. ***Approval by the club shall be in the Club's sole and absolute discretion.***
3. **RECEIPT OF RULES AND REGULATIONS:** ***I hereby acknowledge receipt of the Rules and Regulations of the Club. I understand that my membership is governed by the Rules and Regulations and this application; and agree to be bound to the terms and conditions thereof, as the same may be amended from time to time. I understand that my membership may be terminated or suspended for failure to abide by membership conditions.***
4. **MEMBERSHIP:** ***The Club facilities will be owned and operated by The Ledges Golf Course Company Inc., a Maine Corporation doing business as The Ledges Golf Club (the "Club"). I hereby acknowledge that my membership in the Club is not an investment in the Club, nor does it provide an equity or ownership interest in the Club or the Club facilities. Membership does not confer upon me a vested or prescriptive right or easement to use the Clubs facilities. Members will not have any interest in the income of the Club and will not receive any of the Clubs assets if the Club is dissolved. The Club reserves the right, in its sole and absolute discretion, to modify the Membership and the Rules and Regulations, to reserve memberships, to discontinue operation of any or all of the Clubs facilities, to sell or otherwise dispose of the Clubs facilities in any manor whatsoever, to convert the Club to a member owned club, to restrict or to otherwise reserve the Club facilities for maintenance, golf tournaments and promotional, charitable and other special events from time to time. Membership in the Club is a revocable license, subject to suspension and revocation with or without cause. In the event of any suit between the Club and any member for any claim or matter, the prevailing party shall be reimbursed by the other party for all costs and expenses incurred in such suit, including attorney's fees (including fees required in connection with appellate proceedings).***
5. **HOLD HARMLESS:** I hereby acknowledge that the use of the Club facilities and any privilege or service incident to membership is voluntary and that any use or acceptance of any service or privilege incident to membership is undertaken with knowledge of the risk of possible injury. Each member shall be liable for any property damage and/ or personal injury at the Clubs facilities, or at any activity or function operated, organized, arranged or sponsored by the Club, caused by the member, or the member's guest. The costs of any such damage shall be paid by the member.
6. **GOVERNING LAW:** The Application for Membership shall be governed by and construed in accordance with the laws of The State of Maine.
7. **SEASONAL MEMBERSHIP FEE:** Seasonal membership fees are not refundable nor are they prorated under any circumstances.
